  - Rewrite ordinance for vehicles; should include # of vehicles and # per parcel
  - East Weantchee allows 8; Mansfield allows 5. Suggested # is 5 per dwelling but must meet set backs and fire code
  - Free removal of vehicles; junk vs abandon and must meet criteria
- Shoreline Master Program (Kurt went through with attendees)
  - Shoreline Urban Conservancy designation
    - Ally needs to update and make corrections as discussed
  - Land Use Map and Zoning/Shoreline Designation
- Goals and Policies of Comprehensive Plan and Strategies/Actions of Revitalization Plan
  - Commercial, Transportation, and Economic Elements; Zoning Code

  - Deffered to a future time


